 - Proposed changes to Dance 510
 - Discussed recommendations from the ad hoc subcommittee formed to review Dance 510 and make recommendations for revision
 - Overall faculty expressed support of the plan for Dance 510 to center on a performance project that the first year MFAs decide on their first summer, whether it be a presentational event, participatory event, sitespecific, etc. Will hold space in one of our theaters as an option.
 - Support that the Dance 510 event would replace UW Dance Presents
 during the academic year of the Dance 510 event so that the Department
 of Dance would be presenting 3 productions total during an academic
 year. In other words, would be alteration of Dance 510 event and UW
 Dance Presents every other year. Would still have DMC and MFA every
 year.
 - Was some discussion of when in the academic year to have the event.
 The ad hoc subcommittee recommended in early Winter Quarter; were

- some concerns raised and suggestions to have in late Autumn instead if space can be found
- Was consensus of reducing the Dance 510 credit requirement from 16 to 12. One possible way of distributing these credits (assuming work for the course is done in Winter) is:
 - 4 credits Summer Quarter
 - 6 credits Autumn Quarter
 - 2 credits Winter Quarter
- Still need discussion of what to replace the 4 credits of 510 with possibly a Dance Studies requirement
- Still need discussion of a new course title for Dance 510, and possibly an amended course description for the course catalogue
